Part #50404 – 4 Switch Lighted Non-Fused Rocker Panel Part #50406 – 6 Switch Lighted Non-Fused Rocker Panel

- A. Mount the panel in the desired location using screws provided.
- B. Unroll the wire harness and route all the wires.
- C. Route the wires to their proper location and terminate with terminals provided and using the chart below.
- Note: * 4, 6 & 8 Switch Panels
 - ** 6 & 8 Switch Panels *** 8 Switch Panel Only
- CAUTION: BE SURE TO INSTALL THE FUSE HOLDER AND 60AMP FUSE

PROVIDED BETWEEN THE END OF THE RED WIRE AND THE

BATTERY SOURCE FOR SAFETY.
