



INSTALLATION INSTRUCTIONS

STEP 1. Read the instructions completely before you begin the installation. NOTE: Pictures are for reference only, actual brackets may be different. Installation is the same (some brackets cup the side step)




STEP 2. This installation uses (3) brackets per side. Begin by installing the driver side front bracket. Locate the (2) threaded holes in the underside body panel.



STEP 3. Loosely attach the front front bracket to the body panel using the 8mm hex bolts, and 5/16" washers.





STEP 4. Locate the threaded holes in the body panel, at the center, and rear of the cab.


STEP 5. Loosely attach the marked center and rear brackets, to the body panel using the 8mm" hex bolts, and 5/16" washers.

STEP 7. Align the sidestep with the body, and then tighten all bracket and sidestep nuts and bolts.

STEP 8. Repeat the above steps to install the passenger side brackets and sidestep.

Cleaning and Maintenance

To protect your investment, wax this product after installing. Regular waxing is recommended to add a protective layer over the finish. Do not use any type of polish or wax that may contain abrasives that could damage the finish.

For stainless steel: Aluminum polish may be used to polish small scratches and scuffs on the finish. Mild soap, window or glass cleaner may be used also.

For gloss black finishes: Mild soap, window and glass cleaner may be used.

LIMITED WARRANTY

Smittybilt (The Company) warrants to the original purchaser of this product that should the product or any part thereof, under normal use and conditions, be proven defective in material or workmanship within the warranty period of 5 years from the date of purchase, such defect(s) will be repaired or replaced (At the Company's option) without charge for parts or labor.
