If such should occur, Taylor Cable will make every attempt within a reasonable request and under our warranty guidelines to make the warranty replacement process as smooth as possible.

These ignition wires will withstand temperatures up to 600° F. They are NOT guaranteed against burns from direct contact with a header or exhaust manifold and/or higher temperatures or radiant heat in excess of 600° F. For the best Performance and Protection from heat under extreme conditions, we highly recommend the use of our *Space Age Boot Protectors*, as listed below:

Cost for removal and installation is not included. Warranty is extended solely to the original purchaser.
